THE FIRST PARTY represented herein by its PRINCIPAL (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

#### AND

TECH SATYAM YOGA INSTIUTE, BAHRAICH under U.P Govt. Registration No.-UDYAM-UP-10-0001949, THE SECOND PARTY, and represented herein by its EXECUTIVE DIRECTOR, (hereinafter referred to as "Second Party", institute which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

#### WHEREAS:

i. First Party is a Higher Educational Institution named:

SHRI LAL BAHADUR SHASHTRI DEGREE COLLEGE GONDA U. P. (NAAC Accredited "B" Grade) affiliated to Dr. R.M.L AWADH UNIVERSITY, AYODHYA included under Section 2(f) and declared fit to receive central assistance (UGC grant) under section 12 (B) of UGC Act, 1956 as per approved pattern of assistance under various schemes.

ii. TECH SATYAM YOGA INSTITUTE, BAHRAICH, under U.P Govt. Registration No.-UDYAM-UP-10-0001949, the Second Party is engaged in imparting, Skill Development Educational Services.

iii. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

iv. The Parties intent to co-operate and focus their efforts on cooperation within area of Skill Based Training, Education.



v. Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.

## NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SETFORTH IN THIS M₀U, THE PARTIES HERE TO AGREE AS FOLLOWS:

#### CO-OPERATION

#### CLAUSE-1

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective guidance of the intellectual capabilities of the faculty of First Party, providing significant inputs to them in developing suitable teaching / training systems and keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

#### SCOPE OF THE MoU

#### CLAUSE-2

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry skill. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Curriculum Design: First Party will give valuable inputs to the Second Party in teaching/training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

- Guest Lectures: Second Party to extend the necessary support to deliver guest 2.4 lectures to the students of the First Party on the technology trends and in house requirements as per the syllabus of the course/courses mutually decided in this MoU.
- Both Parties to obtain all internal approvals, consents, permissions, and licenses of 2.5 whatsoever nature required for offering the programmes on the terms specified herein.
- The fee structure of each semester commitment is attached with this MoU on the 2.6 part of the TECH SATYAM YOGA INSTITUTE, BAHRAICH, under U.P Govt. Registration No.-UDYAM-UP-10-0001949 to SHRI LAL BAHADUR SHASHTRI DEGREE COLLEGE, GONDA U. P. (the First Party) to take up any programme mentioned in the MoU.

#### INTELECTUAL PROPERTY

#### **CLAUSE-3**

Nothing contained in this MoU shall, by express grant, implication, Estoppels or 3.1 otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.

#### VALIDITY

#### **CLAUSE-4**

- This Agreement will be valid until it is expressly terminated by either Party on 4.1 mutually agreed terms, during which period TECH SATYAM YOGA INSTITUTE, BAHRAICH, under U.P Govt. Registration No.-UDYAM-UP-10-0001949 the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of Training Partner, the Second Party after termination of this Agreement by way of communication, correspondence etc. shall not be construed as an extension of this MoU.
- Both Parties may terminate this MoU upon 90 calendar days notice in writing. In the event 4.2 of Termination, both parties have to discharge their obligation mutually decided.

# RELATIONSHIP BETWEEN THE PARTIES


#### CLAUSE 5

In case either party is unwilling to settle the dispute through negotiation, either party may submit such a dispute or disagreement through litigation at the local district court of Bahraich. During the period of settling the disputes or disagreement, both the parties shall continue to abide by and perform the mentioned duties and obligation mutually decided in this MoU.
