

# MEMORANDUM OF UNDERSTANDING (MoU)

The broad objective of this Memorandum of Understanding (MoU) is to encourage and facilitate the development of collaborative and mutually beneficial programs, which serves the academic enhancement and literary activities in association with Hindi departments on both the campuses.

Thus the Pompei College Aikala and Sri Lalbahadur Shastri degree college Gonda, Uttar Pradesh have agreed in support of their mutual interests in the field of academic and literary activities.

## **Amendment**

This Memorandum shall not be altered, changed or amended except by instrument in writing executed by the parties hereto.

## **Scope of Agreement**

This MoU incorporates all the agreements, covenants, and understanding between the Parties hereto concerning the subject matter hereof, and all such covenants, agreements and understanding have been merged into this MoU. No prior agreement or understandings verbal or otherwise, of the Parties or their agents shall be valid or enforceable unless embodied in this MoU.

### **Liability**

Parties shall each be responsible for their respective liability. None of the parties shall be responsible for the liability of the other Parties as a result of acts or omissions in connection with the performance of this MoU.

### **Duration of MoU**

This MoU shall be in force from 20<sup>th</sup> February 2020 to 19<sup>th</sup> February , 2025.

### **Monitoring Unit**

The Department of Hindi and IQAC of both the colleges are entrusted to monitor the implementation of the objectives, mentioned in the MoU at the college level.

### **Objectives of this MoU**

1. The two educational institutions will :

a) Co-operate in the exchange of information relating to their activities in the field of Hindi Literature and Research

b) Promote appropriate joint research projects and joint courses of study if any , with particular emphasis on UGC or any other funded programs.

c) Conduct mutual exchange of academic programs such as webinars, workshops, symposium, seminars and short-term courses

d) To organise Ganga-Kaveri (Ganga Kaveri Vyakhyanamala) online weekly Lecture Series in Hindi.

e) Encourage the Hindi literary activities by mutual exchange of expertise

f) Promote research publications and project works particularly in Hindi literature

2) The aim of the Memorandum of Undertaking (MoU) shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both the Colleges.

3) In the implementation of specific cooperative programmes, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the programme.

This agreement will take effect from the date of its signing and shall be valid for five years period from that date unless sooner terminated, revoked or modified by mutual written agreement between the parties and may be extended by mutual written agreement.

Either party may terminate the Agreement at any time during the period of term by the provision of three months written notice to the other party.


